It is very important for you to have a **credit card on file with your vet**, in the event of an emergency should your pet need emergency care and or treatment. Most vets will not perform any services unless they have this on file or have an agreement in place to bill you after you return.

I further authorize the above Veterinarian to give out any information pertaining to my pet(s) to Angel Pets of Houston. In the event of an emergency and if my veterinary office's business hours are not available, then they may go to an Emergency Vet of their choice and I will repay them upon completion for any services rendered.

I agree that Angel Pets of Houston will not be held responsible for injuries, accidents or illnesses of my pets while under their care. Angel Pets of Houston will not be responsible, personally or otherwise, for payment of any veterinary services rendered. I understand that Angel Pets of Houston will use their best judgments to my pets' care and well being.

**VACCINE POLICY**

At Angel Pets we require: Distemper and Parvo within last 3 years. This is often given as a multiple shot DHPP, DHLPP or DHLPP. If you choose to have Blood Titer tests instead of revaccinating we will accept the positive results as proof of immunity. Bordatella within the last year for kennel cough. The vaccine only covers a few of the strains of Canine Cough so it is not a guarantee of protection. Dogs will get over Kennel Cough in 7 to 10 days with out treatment. Rabies within the last 3 years. It is a legal requirement of the City of Houston and Harris County. \_\_\_\_\_ I understand (please initial here). External Parasites: Angel Pets requires that you treat your dog for fleas and ticks. Dogs are checked on arrival and will be treated and quarantined and may even be kept outside if fleas and ticks are detected. (See Boarding Agreement). \_\_\_\_\_ I understand (please initial here)

If there is a medical emergency Angel Pets will do everything in our power to contact you, but that is not always possible and we need to know to what monetary cap you are able to spend on your dog. We have no judgment about this; we just need to be able to follow your wishes.
